

## PHOTOGRAPHY/VIDEOGRAPHY/AUDIO USAGE POLICY

All audio, photography or videography requests must be reviewed in advance and any changes desired (i.e. exhibits rearranged) must be pre-approved. Under normal circumstances, at least one week's notice is required for these requests. A Photography/Videography/Audio Usage Request form must be completed, which describes what the photographer/videopgrapher will be doing. The request will be reviewed and approved by the Executive Director or the Deputy Director. At the approved photo or videotaping time, the completed and approved forms must be presented at the admissions office.

- 1. **Visitor Use:** Visitors to the Museum are welcome to use cameras and video cameras for personal use and not for resale.
- 2. **Media Use:** The "media" refers to radio, television and newspaper. The media is permitted to use cameras and video cameras within the Museum when pre-arranged with the Executive Director, Deputy Director, or Public Relations Manager. A Usage Request form must be completed. <u>Credit must be given to the Virginia Museum of Transportation, Inc.</u>
- 3. **Commercial Use:** "Commercial" refers to private photographers and videographers, movie companies, magazines, other museums, schools, writers and book publishers, and anyone not included in number 1 or 2 above. Commercial use is permitted when pre-arranged with the Executor Director or Deputy Director. A usage Request form must be completed. Credit must be given to the Virginia Museum of Transportation, Inc., or a fee will be charged.
  - a) Commercial use, which promotes the Museum: The Museum does not charge as long as the Museum is promoted and recognized.
  - b) Commercial use which does not advertise or promote the Museum: The Museum charges for use when its buildings and/or artifacts are used for promotion of another business or organization in which the Museum is not promoted or recognized. Fees are determined by the usage request (i.e., after hours usage includes an additional charge for staff time, etc). With regard to the Norfolk & Western Class J 611™, the trademark agreement must be signed and appropriate fees collected in advance of publication.
